In the context of the [EU-OECD Project on Promoting Public-Private Dialogue in Libya](#), the OECD is organising a public sector dialogue on promoting economic reforms in Libya's ICT sector. The purpose of the meeting is to discuss the main challenges facing the sector with the aim of identifying policy priorities for economic transformation and private sector growth. Participants will be asked to provide their views on various issues, namely on improving ICT costs and infrastructure, developing an effective business and regulatory environment, and digitalizing public services.

The EU-OECD Project on Promoting Public-Private Dialogue in Libya aims to support and encourage active economic and social dialogue between public and private sector actors by: 1) Creating a platform which mobilises public-private discussions through physical encounters; 2) Providing the government, private and social actors with the tools and expertise necessary to engage in a structured dialogue; 3) Contributing to developing a new economic vision for the country, delivering analytical inputs and well-structured and specific policy reform plans.

The discussion will be structured around three main challenges for the ICT sector. The discussion will be guided by an issues paper with a set of questions for participants and moderated by Tatweer Research. All participants will have the possibility to share their views through an open discussion.
